VETERAN CHARITIES CAN'T KEEP PACE WITH FAMILIES' REQUESTS FOR HELP

Military and veterans charities are struggling to keep up with flood of requests for mental health care and financial assistance, pointing to serious gaps in available safety nets for vulnerable families, according to a new study from the Bob Woodruff Foundation.

The report, based on responses from 130 community organizations that provide a range of services for military and veteran clients, was con-

ducted in late 2023 and showed slightly more negative results than a similar survey two years earlier.

"Despite an environment of improved employment prospects, the current data show a worsening, rather than an improvement, for many of the most urgent and basic needs, such as help with housing and homelessness, emergency financial assistance, transportation, legal issues, mental health, physical health, and alcohol and substance abuse," the report stated.

"In the face of those increased needs, communities are stretched to serve military personnel, veterans, and their families, with fewer communities able to satisfy those needs fully," the report added. "Most issues that veterans experience are only partially resolved in American commu-



nities."

Of the groups included in the report, 84% reported that most clients requested help getting mental health services or care. However, 71% of those groups' leaders warned that "partner organizations in their community cannot fully address that need."

Similarly, 72% of the groups reported individuals or families requested emergency financial assistance, but 80% of

the groups were unable to provide that monetary help. And 64% of groups reported requests for food assistance, but 68% of the charitable organizations had "insufficient food resources" in their community to meet that need.

Groups surveyed did report success in meeting requests for peer mentorship, social interaction and recreational activities for military families. Also, 94% of organizations said they had resources to partially or fully help with employment-related requests, including directing individuals to job training resources.

Woodruff Foundation officials said the findings point to the need for more attention and resources devoted to challenges facing military and veteran families, as well as ways to increase community support for those priorities.

EXPANSIONS OF VETERAN HEALTH CARE

In one of the largest-ever expansions of Veteran health care, all Veterans exposed to toxins and other hazards during military service — at home or abroad — will be eligible for VA health care beginning March 5

Act

VA announced that all Veterans who were exposed to toxins and other hazards while serving in the military — at home ally, Veterans who never deployed but were exposed to toxins or hazards while training or on active duty in the United States will also be eligible to enroll.

This expansion of VA health care eliminates the phased-in approach called for by the PACT Act — meaning that millions of Veterans are becoming eligible for VA health care up to eight years earlier than written into law. This is a critical step forward because Veterans who are enrolled in VA health care are proven to have better health outcomes than non-enrolled Veterans, and VA hospitals have dramatically outperformed non-VA hospitals in overall quality ratings and patient satisfaction ratings. Additionally, VA health care is often more affordable than non-VA health care for Veterans.

VA encourages all eligible Veterans to visit VA.gov/PACT or call 1-800-MYVA411 to learn more and apply for VA health care beginning March 5. Since President Biden signed the PACT Act into law on August 10, 2022, more than 500,000 Veterans have enrolled in VA health care.

"If you're a Veteran who may have been exposed to toxins or hazards while serving our country, at home or abroad, we want you to come to us for the health care you deserve," said VA Secretary Denis McDonough. "VA is proven to be the best, most affordable health care in America for Veterans – and once you're in, you have access for life. So don't wait, enroll starting March 5th."

VA has determined that Veterans who were exposed to one or more of the following hazards or conditions during active duty, active duty for training, or inactive duty training participated in a TERA:air pollutants (burn pits, sand, dust, particulates, oil well fires, sulfur fires); chemicals (pesticides, herbicides, depleted uranium with embedded shrapnel, contaminated water); occupational hazards (asbestos, industrial solvents, lead, paints including chemical agent resistant coating, firefighting foams); radiation (nuclear weapons handling, maintenance and detonation, radioactive material, calibration and measurement sources, X-rays, radiation from military occupational exposure); warfare agents (nerve agents, chemical and biological weapons); and more. VA will use all available information to determine if Veterans participated in a TERA, including military records and service connection.

For fiscal year 2025, the IB veterans service organizations (IBVSOs) are recommending \$151.8 billion for the Veterans Health Administration (VHA) to ensure that all veterans choosing VA for their care receive timely and highquality medical services. The IB report details specific funding levels and targeted increases for VHA programs, including a \$2.8 billion increase to fill clinical and support care vacancies across VHA; a \$1 billion boost in long-term care to account for the increasing number of aging veterans and their need for essential services; and a \$2.3 billion increase to meet the needs of veterans newly enrolled in the healthcare system, to include those who moved to higher priority groups due to their PACT Act eligibility. The IB recommendations also call for a \$340 million plus-up in dental care to begin expanding this critical service to all enrolled veterans, as well as a \$100 million increase for virtual health care to provide veterans additional options and access, when and where they need it.

The IBVSOs continue to believe VA infrastructure projects, particularly those that will mitigate serious safety risks to veterans and employees, must be fully funded. To accomplish this, the IBVSOs believe Congress must significantly increase funding for VA's major and minor construction programs, and recommend a total of \$6.1 billion for FY 2025. With over \$130 billion in backlogged infrastructure projects, this recommendation would begin to set VA on a path to meet current and future construction needs and make the necessary repairs and maintenance on existing projects. In order to increase VA's ability to manage this larger volume of infrastructure projects, the IBVSOs are calling for VA to increase construction management personnel at every VA medical center across the nation.
