## Thanksgiving A Harvest Celebration

During the autumn of 1621, at least 90 Wampanoag joined 52 English people at what is now Plymouth. Massachusetts. mark a successful harvest. It is remembered today as the "First Thanksgiving."

Thanksgiving today may have little connection with the Plymouth harvest festival 400 years ago, but it has a long history nevertheless. Originally a regional observance in colonial New England, Thanksgiving began as a solemn affair. Rather than a day of feasting, it was a day for fasting and quiet reflection. A far cry from what we do in the present day.

The federal Thanksgiving holiday has its roots in one of the country's bitterest moments of division—the Civil War. On October 3, 1863, President Abraham Lincoln issued this Thanksgiving Day proclamation to help unite a war-weary nation. Lincoln was not the first President to issue a Thanksgiving proclamation, but his order set a precedent to "observe the last Thursday of November next, as a day of Thanksgiving" every year for decades to follow.

In 1941, Congress passed a law in 1941 establishing the fourth Thursday in November as the federal Thanksgiving Day holiday.

So, what does Thanksgiving really mean? Since this is my article, I get to tell you what it means to me. It is my favorite national holiday. Why? There is no pretense. No grandiose speeches. No frills. Just Thanksgiving. A day where I purposely give thanks to God, the Creator of the universe. The Giver of life. I look back over the past year and count my blessings. I let everything else fall to the wayside. I stop and deliberately thank God for all He has done and for all I have. I know I should do that every day of the year, but this day is set aside especially for that.

### VFW to Washington Post - Veterans' Disability Benefits are Not 'Loopholes' to Exploit

The following letter from the VFW National Commander was submitted to the Washington Post on October 07, 2025 [https://vfw.org/media-and-events]

To the Editors of The Washington Post,

Your recent article, "How some veterans exploit \$193 billion VA program, due to lax controls" (October 2025), is not just a disservice to veterans — it is a dangerously misleading piece that feeds into damaging stereotypes and ignores both the moral and legal foundations of the Department of Veterans Affairs disability system.

Let's be absolutely clear: veterans' disability benefits are not charity. They are compensation owed for injuries and conditions incurred in the line of duty — promised by a government that asked men and women to risk their lives and health, often irreversibly, on its behalf. These benefits are not some "loopholes" for opportunists to exploit; they are the very least this country can do for the people it sent to war repeatedly, especially after more than two decades of sustained conflict without a draft.

Your article leans heavily on inflammatory anecdotes and edge cases, portraying veterans as system abusers, while ignoring the structural reality: combat wounds are not the only occupational hazards of military service. The daily grind of service — exposure to toxic environments, repeated concussions, sleep deprivation, moral injury, sexual trauma, constant stress, and grueling physical demands — leaves lasting scars. Just because a veteran wasn't blown up by an IED doesn't mean they aren't disabled.

Invisible injuries like PTSD, traumatic brain injury, and toxic exposure-related illnesses are not "new" or suspect; we just finally stopped ignoring them. Every generation of veterans before this one suffered in silence, and many died without care or acknowledgment. To now say that recognizing these conditions is proof of fraud is not only illogical — it is cruel.

The article also seems to misunderstand how VA disability ratings work. The system doesn't compensate based solely on whether someone can work. It compensates based on how a service-connected condition impairs a veteran's average ability to function in life and society. The fact that a veteran can hold a job doesn't mean their disability doesn't make daily life harder, more painful, or more isolating. If VA ratings

were based solely on complete incapacity, we wouldn't see skyrocketing rates of veteran suicide, addiction, homelessness, or divorce — all of which are fueled not by fraud, but by the very real and too often dismissed cost of military service.



Lastly, let's not ignore what this article really reflects: veterans make an easy scapegoat for the elites of this country. We're a small percentage of the population. Many Americans are disconnected from the wars they authorized or ignored. It is politically and socially convenient to question the integrity of veterans rather than confront the true cost of 25 years of war. But the cost is real. And the obligation to those who bore it is not optional.

If your investigative team wants to find waste and fraud, start with the contractors who overbill, the generals who fail upward, the executives of squandered programs, or the politicians who wave flags while gutting oversight. But don't you dare turn on America's sons and daughters who carried the burden of service and now ask only for the care and compensation they were promised.

We veterans kept our end of the agreement and will continue to demand that those who asked us to defend our nation do the same. **Honor The Contract.**

TSA is partnering with major airports nationwide to designate these special lanes at security checkpoints, and momentum is building fast.

#### Who Is Eligible?

This benefit isn't just for the active-duty service member. It extends to the entire military family. Eligible individuals include:

Active duty service members (all branches,

including Guard and Reserve)

**Veterans** with a valid military ID or VA Veteran Health Identification Card (VHIC)

Military spouses and dependents with DoD-issued ID cards

**Gold Star families** 

In short: If your ID reflects your military connection, you're covered.

#### Where Can You Find It?

The Honor Lane is currently rolling out across select airports, with more locations joining every quarter.

Look for clear signage marked "Honor Lane" or ask a TSA officer at check-in. Some airports also include digital signage or PA announcements that guide eligible passengers to these lanes.

While not yet nationwide, early adopters include:

Atlanta (ATL)
Dallas/Fort Worth (DFW)
San Diego (SAN)

Washington, D.C. (DCA and IAD)

Norfolk (ORF)

Nashville (BNA)

Tampa (TPA)

And more on the way

TSA has signaled its intention to make Honor Lanes the standard—not the exception—at major travel hubs.

#### What Does It Offer?

In short, the benefit offers speed, respect, and relief. Here's what you can expect from an Honor Lane:

Shorter wait times with a dedicated screening line Family-friendly processing, especially helpful when

traveling with young children

More dignity and less stress, particularly for those traveling in uniform, with visible injuries, or navigating the airport with a service dog

And no—you don't need TSA PreCheck to use the Honor Lane, although many military travelers may already have it. This lane operates independently and is designed to supplement—not replace—existing benefits.

#### Why It Matters

Military families are used to waiting—for homecomings, for PCS orders, for the next chapter. But at the airport, you shouldn't have to wait in line just to be recognized. The Honor Lane is one small but significant way to restore time, peace of mind, and a little bit of humanity to your journey. It's the TSA saying: We see you. We thank you. And we've got your six.

#### Final Boarding Call: What You Can Do Now

**Bring your ID.** Your military or dependent ID is your ticket to the Honor Lane.

**Look for signage** or ask a TSA agent at your departure gate.

**Plan ahead.** Not all airports have implemented the program yet, so check your departure location's TSA offerings in advance.

**Share the word.** Tell other military families about the Honor Lane—it's a benefit earned through collective sacrifice.


