This site provides information regarding military personnel, health, and medical records stored at NPRC-MPR.

## New Alternative Caps

Effective September 11, 2025, Section 803 “Manufacture and Use of Seals, Emblems, Badges, Insignia and Uniforms” of the Veterans of Foreign Wars Bylaws has been amended to the following (Amendment in bold italics):

Regulation caps shall be worn by elected and appointed officers at all official meetings. ***Alternative Cap. A baseball-style cap, black in color, lettered with VFW initials, Post numerals, state, rank of office (when applicable), Veterans of Foreign Wars and bearing the Cross of Malta may be worn by members other than officers during meetings of the Post and District. Lettering on each cap shall be in gold. The trim on the front of the bill shall be either gold, green, red, or silver, corresponding to the official braid colors for the respective organizational echelon. The baseball-style cap shall be an alternative to, but not a replacement for the regulation overseas cap and shall not be worn in place of the regulation cap at formal ceremonies, when in business attire, or at events where the regulation cap is prescribed.***



We purchased a dozen of these caps for Post 9934. They will be made available to members at the Post's cost of \$32 each. If you have an interest in obtaining one, please contact the office.

### VFW Marks the 14th Anniversary of the End of the Iraq War

**KANSAS CITY, Mo.** – On Dec. 15, the Veterans of Foreign Wars (VFW) marks the 14th anniversary of the conclusion of the Iraq War. We pause in solemn reflection to honor the service of the more than 1.5 million soldiers, sailors, airmen, Marines and Coast Guardsmen who deployed to Iraq from March 2003 to December 2011 and pay tribute to the nearly 4,500 courageous men and women who made the ultimate sacrifice to protect our nation and advance the cause of freedom.

As an organization comprised of combat veterans, VFW members recognize the tremendous burden carried by our Iraq War veterans and their families, many whom endured multiple, demanding deployments and who often carried the invisible wounds of war as they returned home.

While this major conflict officially ended, the threat remains. The VFW continues to honor the selfless service of our men and women currently deployed to the region to ensure stability, and to help keep us safe here at home.

Please join the more than 1.3 million members of the VFW and its Auxiliary in honoring the veterans of the Iraq War and remembering our brave defenders who continue to carry the torch of freedom forward.
